Participant Agreement, Release and Acknowledgement of Risk 2021 ZeeSpeedTM Youth Endurance Program

- I. I understand that this Participant Agreement, Release and Acknowledgement of Risk is intended to be as broad and inclusive as permitted by the laws of the State of Washington and that if any portion of it is held invalid, I agree that the remaining terms shall continue to be in full force and effect.
- VI. I understand that this Participant Agreement, Release and Acknowledgement of Risk is an important legal document and declare that I have read and considered it carefully. I fully understand its terms and agree that no oral representations, statements or other inducements to sign have been made apart from what is written on this form. By signing this document, I acknowledge that if any one is hurt or property is damaged during my participation in any activity involving services provided by ZeeSpeedTM or ZeeSpeedTM equipment or facilities, I may be found by a court of law to have waived my right to maintain a lawsuit against ZeeSpeedTM on the basis of any claim that I have released by signing this agreement.
